

Dear Applicant,
Welcome to LCC Ice Skating Club (LCCISC). LCCISC is an intra-club of Liverpool Catholic Club and a non-profit sports club managed by volunteer members for the benefit of skating members.

As LCCISC is affiliated with Liverpool Catholic Club (LCC), all applicants must be members of LCC prior to applying for LCCISC membership. LCC membership can be arranged at the main club reception or you can download a form to complete at www.Iccisc.com.au and hand it in at the main club reception. Then present your current LCC membership card, completed form (see over) and preferred payment method to a LCCISC committee member. Failure to present a current LCC membership card at application will result in refusal of LCCISC membership.

LCCISC offers membership for full year (1 Jan 2020 - 31 Dec 2020) and half year (1 Jul 2020 - 31 Dec 2020) with two types of memberships - skating member and non-skating member. The benefits are summarised below. Please note: (1) Non-skating members must upgrade their membership to a skating member if they wish to skate; (2) LCCISC does not offer membership to coaches unless they wish to represent LCCISC in competitions.

Parents of skaters under 18 years of age, please bear in mind that your skater has no voting rights and proxy voting is not permitted within LCCISC Objects and Rules. If you wish for your skater to have a voice in matters that affect them, it is encouraged that you apply for non-skating membership. This enables you to vote on club matters on behalf of your skater. All members over 18 yrs are eligible to nominate for committee positions.

All members are required to agree to the Code of Ethics and Other Guidelines by reading and signing this expression of interest form.

All expressions of interest for membership are subject to approval by the LCCISC Committee, as per the LCCISC Constitution. Your name and membership number will be published on the LCCISC website upon approval of your LCCISC membership application. Declined applications will be notified in writing.

In addition to LCCISC membership, all competitive skating members must apply for NSWISA membership. Please refer to the NSWISA website for application details: www.nswisa.com

Please note that by becoming a member of LCCISC, as a competitor, you can only represent LCCISC; however, you may represent another club for a different discipline only under the condition that the discipline is not offered by LCCISC. Please state the club name and skating discipline on the expression of interest form if this is the case.
