Welcome to LCC Ice Skating Club (LCCISC). LCCISC is an intra-club of Liverpool Catholic Club and a non-profit sports club managed by volunteer members for the benefit of skating members.

As LCCISC is affiliated with Liverpool Catholic Club (LCC), all applicants <u>must be</u> members of LCC prior to applying for LCCISC membership. LCC membership can be arranged at the main club reception or you can download a form to complete at <u>www.lccisc.com.au</u> and hand it in at the main club reception. Then present your current LCC membership card, completed form (see over) and preferred payment method to a LCCISC committee member. Failure to present a current LCC membership card at application will result in refusal of LCCISC membership.

LCCISC offers membership for **full year** (1 Jan – 31 Dec) and **half year** (1 Jul – 31 Dec) with two types of memberships – **skating member** and **non-skating member**. The benefits are summarised below. Please note: (1) Non-skating members must upgrade their membership to a skating member if they wish to skate; (2) LCCISC does not offer membership to coaches unless they wish to represent LCCISC in competitions.

If you wish for your skater to have a voice in matters that affect them, it is encouraged that you apply for non-skating membership. This enables you to vote on club matters on behalf of your skater. All members over 18yrs are eligible to nominate for committee positions.

All members are required to agree to the Code of Ethics and Other Guidelines by reading and signing this expression of interest form.
